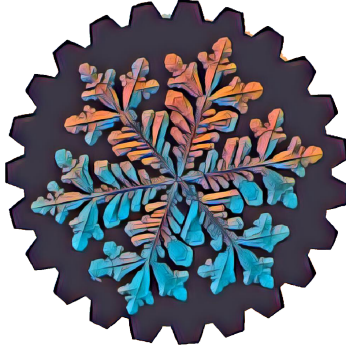

Artist Agreement / Terms & Conditions:

1. Artworks to be brought to the gallery and submitted on November 9 between 5-8pm, or November 10 between 12-5pm at Motion Gallery with "Artist Submission Form" printed. Contract will be signed upon delivery of artwork. One label must be on back of painting, and art listed below.
2. Artworks are limited to 4 wall submissions per artist, additional items for the glass cabinet and prints are also accepted, must have tags and be individually listed in inventory. Fee is non refundable whether one or all pieces are accepted. All art must somehow be suitable for the winter/Christmas show and we reserve the right to reject unsuitable work., please include a short bio about the work.
3. All art submitted must be original and for sale.. All work must be finished and ready to hang, with D rings and wired. **No clip frames or saw tooth hangers**, your artwork will be rejected if not wired properly. Paintings and frames must be completely dry. The gallery will wire your art at \$10 per piece.
4. Artworks will be displayed in Motion Gallery from November 15th, to January 4th. and must be picked up between January 5th. public receptions will be held, November 24th, and a Christmas Art Sale Event December 1st. We will have a few other events to get our art seen and sold!
5. Artworks cannot be removed from the Gallery before to the closing date of the exhibition, unless they are sold.
6. Artworks are to be collected by the artist, if sending someone to pick up your art, please arrange it with Motion Gallery, artwork will not be released without written permission from artist.
7. The artist agrees that their artwork may be photographed and used in any promotional materials now or in the future and at the discretion of Motion Gallery Society.
8. Motion Gallery will receive 15% of payment of Artworks. The artist will receive 85%. Please consider this in your pricing. Payment to the artist will be made within six (6) weeks of the exhibition finishing.
9. By completing, signing and submitting this "Artist Submission Form", the artist confirms that they have read these terms and conditions, and agree to participate in accordance with them.
